- The rates are ZAR (South African Rand)
- The Clients ("function holder's") reservation will be effected upon receiving a signed copy of

These Terms & Conditions completed Reservation Form and the payment of the deposit.

- The venue is only available on the day the venue has been reserved for as specified in the reservation and hire
- Should you, or your representative, require prior entry for setup, or post entry for breakdown, additional charges may be applicable.
- Cancellations will only be accepted by email to vonani@springbokgroup.co.za
- No verbal cancellations will be accepted
- Venue hires for Sundays and Public Holidays will carry a surcharge of R500.00

DEPOSIT REQUIRED

• A deposit, of 50% to secure your provisional booking, is required.

• We will hold the booking on a provisional basis for fourteen (14) days, until a signed copy of this Agreement is received, along with the deposit and the Reservation Form.

• Provisional bookings will be released without notification, should you fail to make payment of the deposit and provide Borwa Lifestyle Centre with the necessary documentation as contemplated above, within the said fourteen (14) day period.

• The full hire charges are payable fourteen (14) days prior to the event failing, which the function will be cancelled, the 75% cancellation fee will be levied, and the deposit will be set-off against the cancellation fee as a payment towards the cancellation fee.

• An additional refundable breakage deposit of R1000.00 will be added to the quote. This is fully/partly refundable within 14 days after the event (depending on damages/losses. The deposit will be retained for the following reasons: Damage to the venue or any other areas of the Borwa Lifestyle Centre Property or not clearing the venue on time as agreed in writing with the Borwa Lifestyle Centre coordinators; and or not adhering to the rules as stipulated in this Agreement.

• This deposit will be held by Borwa Lifestyle Centre as security for any damages it may suffer arising from the function.

• Should there be no damages or breach of contract suffered by Borwa Lifestyle Centre, within the sole discretion of the Borwa Lifestyle Centre Management, the deposit will be repayable to the function holder within seven (7) working days after the function date.

CANCELLATION POLICY

The following cancellation fee will be charged by Borwa Lifestyle Centre to the Client, in the event of cancellation of any advance reservation or booking:

- 30 Days prior to arrival a 15% cancellation fee will be levied on the full value of the quotation.
- 21 Days prior to arrival a 25% cancellation fee will be levied on the full value of the quotation.
- 14 Days prior to arrival a 50% cancellation fee will be levied on the full value of the quotation.

• 7 Days or less prior to arrival a 100% cancellation fee will be levied on the full value of the quotation.

THE PREMISES

1. The premises shall always be under the control of the Borwa Lifestyle Centre which reserves the right to impose any terms and conditions in addition to those contained herein, as it may deem necessary, in order to ensure that the rights of other visitors to Borwa Lifestyle Centre, the neighbours and others are respected.

2. The Venue Hire is restricted to the Borwa Lifestyle Centre only.

3. There are limitations to amplified music. All music both amplified and unamplified must be restricted to the inside of the Borwa Lifestyle Centre. Under no circumstances may PA speakers be directed to or placed on the outside of the building. All music must be turned down by 18h00 and must be kept at an acceptable volume that does not cause disruption or disturbance to the surrounding/neighbouring areas.

4. The client's arrangements for music should be discussed with and approved by Borwa Lifestyle Centre Management. Any request by Borwa Lifestyle Centre Management for music volume levels to be reduced must be complied with. If in the opinion of Borwa Lifestyle Centre Management, the pre agreed noise levels are exceeded, the full deposit will be retained.

5. TAKE NOTE that we have a swimming pool on the premises and is available at own risk. Children must always be accompanied by parents or by adult supervision.

6. The Client and Borwa Lifestyle Centre Management should meet one week prior to the function to discuss procedures for the event as well as special requests. All role players should be present to be involved in the process. The following items need to be covered in this meeting:

- Security arrangements
- Closing times
- Venue hire will only be for three hours from start of your event.
- Parking arrangements
- Other logistics

7. The function holder must ensure that the premises and audio-visual equipment are returned to Borwa Lifestyle Centre in the same good order and condition in which they were found.

8. Borwa Lifestyle Centre will not be held responsible for any reason whatsoever for the nonfunctioning of any equipment brought onto the premises by the function holder.

9. The function holder will be responsible and liable for any damage or loss caused to Borwa Lifestyle Centre by any of the sub- contractors hired for the function.

10. Borwa Lifestyle Centre and/or its staff will under no circumstances be liable for the loss, damage and/or theft of any of the sub- contractor's equipment or loss or damage to any property of the guest attending the function.

11. All functions must end by time agreed upon. Should functions not end by time prior agreed on, Borwa Lifestyle Centre reserves the right to retain the deposit.

12. Maximum numbers will always be adhered to. Failure to adhere to maximum numbers will result in the function being cancelled.

13. Final numbers must be confirmed three (3) days before your function.

14. The function holder must observe the set up and break down time referred to in the reservation and hire form.

15. All refuse must be removed by the function holder immediately after the function or taken to the recycling depot. Unwashed crockery and cutlery must be placed in sealed containers for hygiene purposes.

16. All equipment brought onto the premises by the Client or any of its contractors must be removed from the premises within 24 hours.

17. Please note that setting up the venue remains the Client's responsibility.

18. The deposit paid by the function holder will be forfeited should any of these rules not be strictly adhered to by the function holder, its sub-contractors and/or its guests.

19. Host for the day: Borwa Lifestyle Centre will have a host present until your function ends. She/he will be available to assist you with any problems that may arise during the event. The host is paid by Borwa Lifestyle Centre.

PUBLICITY

1. Borwa Lifestyle Centre must approve all publicity and advertising relating to the function.

INDEMNITY

1. The function holder indemnifies Borwa Lifestyle Centre for any claims for damages, injury, or loss by any person(s), including its guests, arising out of the function held at the premises.

2. The client will be responsible for the safe keeping of, or damage caused to equipment hired on their behalf. You hereby agree, as a condition of your occupation of the premises that Borwa Lifestyle Centre and the owner, manager and/or operator of the premises and their affiliates and respective director, officers, employees, agents and representatives (COLLECTIVELY " Borwa Lifestyle Centre ") shall not be responsible or liable for any accident or any injury or death of any person or the loss destruction of

SEVERABILITY
